She mentioned a disk test to test clarity. She checked it and said the lake looked good. Several lakes had to put in new septic. She said the weed patches help filter the lake. She also said to keep in mind that there are more year round residents that are using more lawn products that are going into the lakes. She said that the trailer court and dairy farm are not a concern because they are licensed and inspected by the state. She said that Blue has a different lake bottom and is spring fed and is better off than many lakes. Karen suggested that we may want to put the info about lawn products in the newsletter. It was also suggested to have a welcome packet for new neighbors that includes information about lake health.

There was discussion about making more readable signage about no wake hours.

Elections: Steve, Patti, Dave and Ray ran unopposed and were approved for new terms.
